A. Admissions to the above-mentioned Class at SVKM'S Narsee Monjee College of Commerce and Economics (Autonomous) will be through ONLINE SYSTEM.

1. Applicants have to fill the form ONLINE only.
2. Applicants are required to fill a separate form for each category under which he/she wishes to apply i.e. if a candidate belonging to Gujarati Speaking Linguistic Minority wishes to apply under Gujarati as well as Open Category, he/she will have to submit two separate applications and will have to **pay Rs. 100/- with each form.**
3. The procedure for online submission - APPLICATION FORM:

Kindly Note:

- The online application must be made within the specified dates stipulated by the college.
- You have to create a single user id on portal by clicking on Register Now. Once you register and your login credentials are created, you need to go further for filling online application form.
- The application-processing fee will be charged as per the number of programme you have applied for.
- Kindly fill in all the mandatory fields i.e. fields marked with *.
- Check the information entered by you in the application form carefully before submitting. Once the application is submitted, no changes can be made thereafter.
- For any corrections in the admission form kindly send an e-mail at nmformcorrections@nmcce.ac.in.

- Making online application does not mean that you have secured admission in any of the course. After the submission of the form, kindly proceed for payment of the processing fees.
- For Online payment use ‘Check Application status’ link on the portal & go to the Pay registration tab & click on that to proceed with the payment of admission processing fees. Kindly note that your application will be considered only after successful payment of processing fees.
- After verifying that the information filled is correct, the candidate must now click the “Submit” button to submit the form. An **APPLICATION NUMBER** is generated on submission of the form.
