2. Mumbai University Enrollment Form.
3. Self-attested Marksheets of All Semester Examination or Equivalent Examination (Kindly bring Original for Verification)

4. In case if SGPA/CGPA is mentioned on Sem I to VI marksheets, a letter from the college confirming marks obtained subject wise duly authenticated by the competent college authority.
5. Self-attested Marksheets of Std. 10th & Std. 12th (Kindly bring Original for Verification)
6. Students having break in any academic year should submit the Gap Certificate (Affidavit) on a Stamp paper of Rs.100/-.
7. Original Migration Certificate from their University (for those other than University of Mumbai), to be submitted.
8. Self-attested photocopy of Aadhar Card (Kindly bring Original for Verification)
9. Additional Documents for the Students seeking admission under Gujarati

Linguistic Minority:

If student is Gujarati by birth, following documents can be accepted as a proof
(ANY one of the following)

- a. Copy of the Vastipatrak (Cover page plus the relevant page where the name of the Applicant appears along with the names of his / her parents).
- b. 12th Std. (or equivalent) / 10th Std. (or equivalent) marksheet of either parent, showing Gujarati language being opted in either of the examinations.
- c. Certificate from the Head of the Community / Trust / institution (Government recognized having Trust Registration Number) confirming the claim.
- d. 12th Std. (or equivalent) / 10th Std. (or equivalent) marksheet of the student, showing Gujarati language being opted in either of the examinations.

In case if the student is not GUJARATI by birth, but the mother of the applicant is Gujarati:

- a. Marriage certificate of mother indicating mother's name, along with marksheet of H.S.C (or equivalent) / S.S.C (or equivalent) showing that mother had opted for the Gujarati language as subject in any of the aforesaid examinations.
- b. Certificate from the Head of the Community / Trust / institution (Government recognized having Trust Registration Number) confirming the claim.
- c. Copy of the Vastipatrak (Cover page plus the relevant page where the name of the mother appears along with the names of her parents).

 - f) Document for Transfer Cases Category: Govt. Transfer Order specifying date of transfer.
 - g) Document for Fee concession: Relevant document. (From Government of Maharashtra only)
 - h) Students (Girls) who are Widows/Divorcee: Relevant document
