Subject: Admissions to the UG Programs for 2023-24 through CUET (UG)- 2023-24 to be conducted by NTA

Admissions to all the UG Programs (Self Finance Programs & B.Com Outsiders' Category) at Narsee Monjee College of Commerce and Economics (Autonomous) for the Academic Session 2023-24 will be held through Common University Entrance Test- CUET (UG)-2023 being conducted by National Testing Agency (NTA).

Candidates seeking admissions are advised to go through the CUET-23 Admission Bulletin on the CUET website <https://cuet.samarth.ac.in> and get further information about the test. **The last day for online registration for the CUET test is 30th March 2023. Refer to the CUET admission notice attached.**

The admission to N.M.College will be given based on **equal weightage to class XIIth marks and CUET score.**

The CUET score of the 'General Test' category (Code: 501) will be considered as the component for admission purpose.

The Registration for Common University Entrance Test [CUET (UG) – 2023] is live since **09 February 2023**. Meanwhile many new Universities / Institutions / Autonomous Colleges / Organizations have also joined CUET (UG) - 2023. In order to ensure that more options are available to the applicants for choosing courses / programmes of various newly added Universities / Institution / Autonomous Colleges / Organizations from all over the Country, it has been decided to **extend the online Application Form for the CUET (UG) – 2023** as per the details given below:

Last date for payment of fee online	30 March 2023 (Up to 11:50 P.M.)
Correction in particulars of online Application Form	01 April to 03 April 2023
Announcement of the City of Examination	30 April 2023

The dates of downloading of Admit Cards, and declaration of Result will be displayed on CUET (UG) portal at the appropriate time.

Those candidates who have already submitted their Application Form successfully are also **eligible to choose more Subjects (Tests) / Courses (Programmes) / Universities / Institutions / Autonomous Colleges / Organizations. The candidates who have already selected 10 subjects/tests, can also replace / remove their earlier chosen Subjects/Tests. However, additional fee (if applicable) for selecting more subjects (tests) will be paid by the candidate. Candidates may note that fee once paid will not be refunded.**

Refund of Duplicate fees (if any) to the concerned candidates (wherever applicable) will be initiated only after the reconciliation of fee data of all candidates as received from the concerned Banks/Payment Gateways Integrators with the fee data captured during the online Application Form of CUET (UG) - 2023.

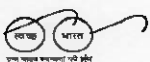
