A Candid interview with Ms. Amee Vora – Her transition from being an NM student to being an in-charge Principal of NM College

Q. How has your journey from a professor to a vice principal and now to the In-charge principal been so far?

Little did I know when I entered this temple of SARASWATI IN 1983 as a student in FYJC that I shall be giving an interview to you as the Principal In-charge of my alma mater? Being an In-Charge Principal of this very prestigious institution brings along with itself a lot of responsibilities and it is also very demanding. Every stakeholder looks up at the new head with a lot of expectations. Expectations to bring about conducive change...

Q. As an NMite, NM then and now, what in your opinion has changed?

As a student I was really simple and felt privileged to be a part of this college. I stepped into a lot of folk dancing in college, elocutions, cultural society and yes I had joined the WNC too. Those were the days when college was a lot more buzzing being the only huge platform to students. Even then, there were CAs but they had that time for the college. And slowly, opportunities changed, the generations and mind-set changed 360 degrees and now a 21 year old is much more aware as compared to a 21 year old back then. We always tend to resist change, but change is definitely for the better.

From 1983 till date NM has come a long way. We neither did have air-conditioned classrooms with LCD projectors nor the state of the art library with E-Resource Centre, the various databases and ejournals that are available for the students as well as the faculties today. The college has kept pace with time and has adapted itself very well to suit the technological needs of the students as well as the faculties. We did not have our own festivals then as we have now, Umang and Drishti. The only Inter-collegiate festivals that we used to participate in those times were Malhar by St Xaviers College and Mood Indigo by IIT. The Inter-Collegiate Youth Festival by the University of Mumbai was always there. The students took keen interest in participating in the festival as we had only a few inter-collegiate festivals in which we could participate unlike today, where we find

every other college in the city having its own intercollegiate and the students are getting enough opportunities to participate and showcase their talents. This has also enhanced their organizing and leadership qualities and it has given them the confidence to market their events and get good sponsorship for their programs and events. Our NSS unit was always active even when I was a student and to add to the social and community service we have added one more association today, that being, the Rotaract Club of NM College.

Q. What transition have you witnessed in the college particularly in the students from the year you joined till today?

When I joined this college as a lecturer in 1992, students were always intelligent, diligent and were pursuing CA. Our students are more focussed, they know well in advance what they wish to achieve in life and start working towards their goals right from their college life. It is sad, however, that to keep pace with this rat race, they miss out on their five years of college life which they shall never get back once they graduate. I strongly believe that even when our students are talented they are divided between their careers and their love and passion for their talent. In this tug of war they end up giving greater preference to the former.

Q. What changes do you seek to bring about in college?

Our college offers not only the traditional BCOM program but also offer a Bachelors in Management Studies, Accounting and Finance and Financial Markets as well as a Bachelor of Science with Information Technology. With a plethora of options available to the students, it is necessary to ensure that our students who graduate are employable and ready for industry induction. The apparent need therefore is to bridge the gap between the academia and industry requirement and introduce such value added, skill based courses that shall make our students employable. The training and placement cell of our college is doing a commendable job by giving our students training in soft skills as well as placing them with

firms with an average pay package of rupees 3 lakhs per annum. Presently, the highest package received is rupees 7.5 lakhs per annum.

Q. What is your opinion about the functioning of our various college associations?

Our college has over 30 associations catering to different interests of our students and covering all possible aspects of co-curricular and extracurricular activities. But although each association wishes to conduct activities of different kinds the committee members of these associations always have a fear that the programs shall not be attended by a large number of the student population and hence all their efforts to put up a good event shall go in vain. It is therefore, the responsibility of our students to ensure that the activities go on thriving with enough participation and involvement as these activities are responsible for grooming the students in leadership, team building and organizing skills, apart from giving them a platform to excel in cocurricular and extra –curricular events.

Q. From Dramatics to teaching, how did the transition happen?

Dance & Dramatics has always been a part of my student life and I have actively participated in them all through college; even abroad. The opportunity to teach as a professor at NM arose after I completed my M.Com. Since then, there has been no turning back for me. Teaching has, and will always be my passion. It makes me immensely glad to be a part of this honourable profession as it allows me to selflessly propagate the knowledge I have to my students.

Q. Which'T' is more passionate for youTeaching or Theatre?

We all have some passion or a hobby that we would like to pursue and which acts as a stress buster. So when u like doing something and enjoy it, you neither feel the pressure nor the stress and therefore, you must pursue your hobby and keep the fire burning within you. A hobby or a passion also cultivates within us a sense of dedication and devotion which sharpens our skills and concentration levels for any task on hand.

A teacher apart from having good knowledge about the subject and a command over the medium of instruction should also possess good communication skills. He or she must be able to make the subject as interesting for the student who is his or her audience in class and ensure that they all are completely involved in the class. A good dramatist also needs to be a good communicator and has to ensure that the audience listens to whatever is being spoken on stage in rapt silence. So it is not about a winning edge it is all about how you are putting your talent to best use in real life situations. I am very passionate about teaching as well as theatre and therefore, I enjoy both.

Q. Does the change in your present title makes you feel any different?

I think, I'll leave this question to the staff and students to answer for me. I still feel I am the same person and it's just that I have walked a few steps into another cabin. But yes, it has definitely given me the fulfilment to do something that I would want NM to be like and I hope I'm able to deliver the little bit I can in the span of time that I have.

Q. What message do you wish to give to our young NMites?

In the end I would like to tell you, my dear students, that college life is one of the sweetest memories that you can ever have. You meet and make new friends. They pore over the text books with you, drink innumerable cups of coffee with you and exchange views with you. And then as mature qualified adults when you enter the world, you shall be working and meeting all sorts of people and your experience here in college will tell you that it is a good thing that the world is full of wonderful people with different ideas and talents. You shall be ready to take the chances, update your knowledge, add to your skills and be ready to cope with change.

Every milestone I have crossed at NM, be it my graduation, my term as a professor, becoming the Vice Principal or being appointed as the In-Charge Principal in September 2015, I owe it to my alma mater. I shall strive to serve our wonderful institution-Narsee Monjee College of Commerce and Economics to the best of my ability with great pride and dedication.

Recognition:

The facility for accessing e-journals and e-books using NLIST database of UGC-INFLIBNET and e-journals and many other databases facility provided by NMIMS University library to our college library with individual ids and passwords was used by many students and teachers. Since this facility was provided

through proxy server, it is now accessible from any computer within the campus as well as outside the campus. Some other important online resources such as RBI Bulletin, government websites related to economics and statistical information, etc. were provided with their URL as hyperlink through the library webpage on the college website, where these could be easily accessed. The details of these e-journals and e-books databases and online resources were also provided to all students through printed library brochures, library newsletters and google groups.

Stock of Library:

Into the greatest assets of the college, the Library's books collection, increased by 1281 new books (costing Rs. 442985.00). Library subscribed 94 journals and magazines (89 national & 5 international), out of which 'Chhatrarth' and 'Journal of Management Research' were newly subscribed. The library has institutional membership of British Council Library, Indian Commerce Association and Maharashtra Economic Development Council. The library also has collection of maps and DVDs related to various subjects.

Services to students and teachers:

- Every day more than 600 students visit the library for various purposes like using reading room, books issue, journals/ magazines reading, question papers, project related references, asking for how to use e-journals or e-books, using UGC-NRC, or many other simple queries.
- The printed library brochures were distributed to all students in the beginning of the year to make them aware about their library facilities and resources.
- The Subject Bibliographies useful to save time of users were prepared for Make in India, Export Management, Transport Management and Tourism Management.

- Question papers of previous years for all examinations were prepared as booklets. On students demand we are scanning the past question papers and providing the soft copies of the same through UGC Network Resource Center.
- Photocopies of latest syllabi and past question papers were provided to the teachers, whenever they required.
- The material prepared for career guidance was updated and given for Master Mind program.
- We provided the reference service with the help of documents including books, journal articles, magazine articles, newspaper clippings, ejournals, internet articles, etc. throughout the year. The appropriate subject related newspapers clippings, information about databases of e-books and e-journals, computerized lists of books and contents lists of journal articles were provided to the faculty members and students as a proactive information service.
- Book-Bank Scheme: In the Book-Bank scheme 178 books were issued to 23 students from the Student's Aid Fund.

Services to Ex-students:

- During this year the certified copies of syllabus were issued to 11 students going abroad for further studies.
- This year 132 ex-students used the comfortable and centrally air-conditioned reading room of the library for their CA, CS final examination and entrance exams studies. Due to this facility we found that many regular students get benefit of the past students experience in these courses and studies.

Library Newsletter:

Online newsletter of library was published every month on the college website. This newsletter is



giving information about the library's collection, service provided to students and various available databases in detail. It also displays photographs of 'Happy Moments in Library' and 'Friends of Library'. The second part of the newsletter is dedicated to students, where students contribute articles, poems, quiz and information for publication.

Encouraging Reading:

Our aim is 'not to leave any student unattended or dissatisfied' and we try our best to satisfy the career and curricular related requirements of every student approaching us. The motto of our library is 'Encourage Reading'. For this purpose the library takes many actions as below.

- Providing an additional library card
- Open access to all students
- Promptly display newly arrived books in the book showcases near the library entrance
- Purchase books recommended by students and display those on notice board along with the student's name.
- Students were also asked to select from the books received on approval
- Book reviews written by students were displayed in showcase along with the book as "Book of the Day" and these books were mostly demanded for reading by students after display. These book reviews are bound together for the future use.
- Circulate reading lists of books along with book reviews through Google Groups
- Display newly added books covers in library newsletter and newsletter is published online as well as sent to all students through Google Groups.

Library Committee:

The library committee decided the subject-wise budget distribution for the academic year. The committee scrutinized applications received from students for Book bank facility provided for the financially weaker students of our college. The committee also suggested some norms to be followed by the library for students' admission cancellation. The Library Committee meetings were held on first Saturdays of the month to discuss on students suggestions regarding improvements of the library facilities and giving their opinion on those suggestions. The student's suggestions along with the actions taken on those suggestions and students' recommended books purchased by library were displayed on the library notice board to make the students awareness about this facility.

The above achievements by the library would not have been possible without the timely guidance from the Principal and the capable and dedicated library staff, who performed their duties with honesty and enthusiasm and very positive contribution by Friends of Library and our students.

Review Report on Refresher Course in Business Studies

The world is fast changing with rebalancing of manufacturing and consumption weight across the developed and developing economies. China emphasizing on increasing their consumption capacity by phasing out single child policy, Russia facing geopolitical issues and tremors from terrorist groups. USA and Mexico on the other hand are reclaiming their share of the global manufacturing pie on the back of the declining factor and rising productivity. India too gears up for restructuring their sectoral contribution from existing share of 15% in overall GDP which compares poorly with pears like Malaysia, Thailand and Indonesia, to 25% of GDP through Make in India policy. The NDA launched Make in India policy on 25th September, 2014. The program which promises to promote India as an important investment destination and global hub for manufacturing designs and innovations. The policy aims to transform the economy from a service driven growth model to labour intensive manufacturing driven growth and target on creating 100 million jobs in manufacturing sector by 2022.

SVKM's N.M. College of Commerce and Economics on behalf of the Human Resource Development Centre of UGC organized a Refresher Course in Business Studies for the Professors, across the colleges under University of Mumbai. The course was held for three weeks from 7th December 2015 to 26th December 2015. There were 46 teacher participants who attended the course. This was the tenth refresher course batch organized at NM College. During this course, 38 guest lectures were held and a field visit was organized to Welspun, Vapi. The teacher participants also carried out three academic activities during the course. The activities were Seminar Presentation, Group Discussion and Research Proposal Presentation. The contents of the entire refresher course were objectively selected and the quality of speakers were supreme. This led to enhance the knowledge of teachers about the contemporary developments in their subjects and also to provide an understanding about the emerging areas of Make in India policy.



Business Plan Competition - 2015

Intent's Flagship Event, The Business Plan Competition was conducted during July- August in two phases.

The first phase of the Competition included submissions of Business Idea Overviews on the basis of questions related to their Business Plans Idea. In this phase total 45 teams submitted their business idea overview. The results of first Phase was declared on 24th July and the Orientation for the semi-finalists, explaining them the Do's and Don'ts of Phase 2, was held on 25th July 2015. A Feedback Report by the Judges was given to all the teams about their respective plans were given to all the teams irrespective of winner or not. In Phase I total 15 plans qualified for the Second Phase of the competition.



The second phase was conducted on the 10th and 11th of August 2015. Each team presented their business plan to the judges followed by answering the questions asked by them. The event was judged by Mr. Varruchi Dubey, Mr. Dhaval Doshi and Ms. Sonakshi Pratap along with faculty members Mr. Huzefa Bhagat and Mr. Samir J. Dave. This session helped the participants to think, re-work and develop their ideas further. In the second phase 6 teams were selected for the semifinals.

Intent held a B-Fair on 20th August, 2015 as a part of Business Plan Competition. The B-Fair hosted seven teams to present their business ideas to the students and faculty of NM College. Members of the audience were invited to cast their vote for the business plan they believed had the most to offer and the winning plan received a wild card entry into the Finale of the Business Plan Competition. In B-Fair Raj Doshi (!nspiro- Go Awesome) gained maximum votes and selected as a wild card entry in the Finale.

These seven semi-finalists were provided one-on-one mentorship from successful entrepreneurs who are N. M. Alumni and who provided further insights and guidance to these students on their business plans. The mentors were Mr. Jagdeep Kapoor (Chairman, Samsika Marketing Consultants), Mr. Atul Tibrewala (founder, Cartridge Junction), Mr. Ankush Agarwal (Co-Founder, Global sales at PE Front Office Solutions), Mr. Vinit Rughani (Head, Business development at IISA, CS, CFP, CFA(L2)), Mr. Karan Thakkar (Founder, EcoCentric Management Pvt. Ltd.), Mr. Ashutosh Rathi (Director, English Enablers).

The final round of Business Plan Competition was conducted on 28th August 2015. Seven finalists presented their Business Plans before the judges followed by Question and answer session from the judges. Business Plans were evaluated on the basis of Innovation, Feasibility, Financial Analysis,

Competitive Advantages and HR Analysis being a few. The Judges and the Mentors proved to be inspirations through their valuable inputs and experiences.
