MEMORANDUM OF UNDERSTANDING

between

Shri Vile Parle Kelavani Mandal (SVKM) and Truecopy Credentials Pvt Ltd, Pune (TRUECOPY) Effective as on 03/02/2025

NMIMS (deemed-to-be University) and other colleges/institutes under SVKM, autonomous and affiliated to University of Mumbai issue transcripts to their students who desire to apply to overseas Universities other destinations. TRUECOPY facilitates sending these transcripts electronically to receiving universities and other destinations. This ensures speedy delivery, acknowledgement of receipt and also lesser cost, which benefit the students.

The purpose of this MOU is to establish the terms of collaboration between SVKM and TRUECOPY to provide electronic transcript delivery service to the students of SVKM.

- 1) TRUECOPY will provide an online system to enable the students of SVKM to send transcripts electronically to Overseas Universities and other destinations over the Truecopy Transcript Network.
- 2) The system provided by TRUECOPY will include
 - a) Transcripts application link on websites of NMIMS and other colleges under SVKM
 - b) Online Transcript application form to be filled by students including ability to specify receiving universities
 - c) Online Approval of Transcript applications by competent authority of the NMIMS or SVKM as the case maybe. Online payment gateway for students to pay the transcript delivery charges
 - d) Delivery of secure transcripts to the destination University
 - e) Email acknowledgement of delivery to student
 - f) Student analytics/reports

- 3) For Universities that are not in the network, TRUECOPY will get paper transcripts approved and attested from the competent authority of NMIMS or SVKM as the case maybe and will post the sealed envelope to the address specified by student. The application process will be same as points 2) a to d outlined above.
- 4) SVKM agrees to facilitate the electronic transcripts system and agrees to approve and upload the pdf copy of the transcript based on its student records onto their secure account on TRUECOPY, and TRUECOPY agrees to provide support to enable this.
- 5) SVKM agrees to publicize the TRUECOPY service to its students who wish to apply to universities overseas.
- 6) There are no subscription charges to SVKM.
- 7) TRUECOPY will charge an application fee of INR 1280 + SVKM charges directly to the student. This fee includes the approved soft copy of the transcript and 2 e-transcripts delivery OR 1 hard copy to universities. Refer to Appendix A below
- 8) TRUECOPY will charge per additional electronic transcript delivery directly to the student @ INR 750 per overseas Universities, other destinations and @ INR 350 + SVKM charges/paper copy. Courier charges will be extra at actual in case the transcripts are to be mailed locally or overseas by DHL Refer to Appendix A below.
- 9) TRUECOPY will charge INR 500 to send the official transcript to a destination email address. Refer to Appendix A below.
- 10) TRUECOPY will charge INR 200 + SVKM charges per student to issue the Statement of Marks. Refer to Appendix A below.
- 11) GST (18% or as per the prevalent regulations) will be additional and applicable on as per prevalent GST regulations.

- 12) TRUECOPY will pay SVKM a sum of university charges per transaction by the 10th of the following month.
- 13) This MOU is valid for 5 years from the effective date. Either party can terminate this agreement during the period of the agreement by issuing a written notice of 1month.
