IN-HOUSE STUDENTS should fill the form **ONLY UNDER IN-HOUSE CATEGORY and NOT in any other category.**

Students from SVKM'S Narsee Monjee College of Commerce and Economics (Empowered Autonomous), as IN-HOUSE STUDENTS. Students should register on the portal with a new login id and password. (Junior College/School SAP id and password are not functional)

- In-House students belonging to Gujarati Linguistic Minority/ Gujarati Speaking Community will have to secure admission under IN-HOUSE category only.
- Students who have appeared for H.S.C. examination through NM College under Form 17, as a private candidate are NOT considered as in-house students. They will have to fill the form in OPEN Category as and when the admission portal is open.
- **For Self-financed program, In-house category DOES NOT apply.**
- All Students of In-house category must **First secure their admission as per the given schedule only**, failing which they may not be considered for admission at a later date, under the category of In-House.
- The students are required to register on the site of Academic Bank of Credit/APAAR ID as it is mandatory. If not registered, click on the link:- <https://www.abc.gov.in>



STEPS TO BE FOLLOWED

- 1. FOR INHOUSE STUDENTS (F.Y.B.COM.) AIDED COURSE:**
Applicants aspiring to take admission in NM College should fill in the online **Pre-enrollment form** of University of Mumbai from **<https://mu.ac.in/admission>** from **8th May, 2026 to 12th May, 2026** up to 11.59 p.m. under **AUTONOMOUS** category (as NM College is an autonomous institution) & take printout.
2. Register online for filling up the **Admission form** of NM College on the following link:
<https://sdcappscs.svkm.ac.in:44300/irj/portal> from **13th May, 2026 to 21st May, 2026** up to 11.59 p.m.
3. Applicants are required to save the application form.
4. Applicants are required to make the **mandatory online payment** of Rs.500/- as admission processing fees, **failing which their form will not be considered for merit list generation and for admission.**
5. Kindly note that the name of student in the admission form, should appear as per Mumbai University form and **TOTAL MARKS** (and **NOT BEST of FIVE**) obtained in all subjects.
- 6. Second Merit list** will be displayed on **22nd May, 2026 at 7.00 p.m.** on the college website, followed by schedule of submission to **OFFLINE** Admission form & Payment of Fees on **23rd, 25th & 26th May, 2026** between **10.00 a.m. to 3.00 p.m.**

- **Incomplete forms will not be considered for admission.**
- **In-house students failing to fill the form under in-house category, within the stipulated time, will LOSE THEIR CLAIM FOR ADMISSION UNDER IN-HOUSE CATEGORY.**
