1. The students claiming admission under the Gujarati Minority quota will have to submit :

- Undertaking of Gujarati linguistic minority.
- An attested copy of the following documents:
- Certificate of Gujarati Minority issued and signed by the head of the Registered Community on its letter head (Government recognized) confirming the claim (for students) of being Gujarati.

OR

- Vasti Patrak

- Mark Sheet/School Leaving Certificate of any one parent having studied in Gujarati Medium. (Additional document)

If the student is not a GUJARATI by birth but the mother of the applicant is a Gujarati, the marriage certificate of the mother indication her maiden name must be produced for verification along with the following documents of the mother as a proof of being Gujarati

- Certificate of Gujarati Minority issued and signed by the head of the Registered Community on its letter head (Government recognized) confirming the claim (for Mother) of being Gujarati.

OR

- Mother's Vasti Patrak
- Mark Sheet/School Leaving Certificate of mother if she has studied in Gujarati Medium. (Additional document)

Note :

- * **Student should be domicile of State of Maharashtra.**
- * **In case of doubt, the college authorities can ask for more than one document for verification of Gujarati Minority status.**

2. Printout of post admission form. (Available on respective college website for filling)

Note: Applicant's name appears in the merit list, then he/she will log in again to the concerned college website's post admission form link with the same login id and password used for filling the first part of the form. He/She will click / select the "Gujarati Minority Post Admission Link" button and fill the form, update and save the form. Take the hardcopy i.e. The print out of the form. Kindly note the form will bear the same application number which was generated on submission of Pre-Admission form, he/she will be required to secure the admission by paying the requisite fees and submitting the following documents.

3. Original Mark sheet of Xth Standard Examination and 2 self-attested photo copies.

4. Original School Leaving Certificate along with 2 self-attested true copies (Please keep at least two certified photo copies of the School Leaving Certificate for your future use)

5. Three recent unused copies of photographs of identity card size (3.5 cms x 3.5 cms)

6. Photocopy of the Aadhar Card.

7. Proof of residential address.

8. Photo copy of the Government Online form (Part-1 Registration Form and Part-2 Option Form).

ICSE students have to submit Part 1 and Part 2 as per the new rule.

9. The receipt of online payment.
